ORDER:-

In the reference 1st cited, Sri Sagi Appala Narasimha Raju & others have applied the proposals for approval of layout in an extent of Acs.6.92 cts. covered in Sy.Nos. 21/P, 25/P, 33/P & 34/P of Kondakarakam (V), Vizianagaram Mandal & District.

The applicant has paid Rs.6,55,182/- vide 1) VUDA Receipt No. 2997/2016-17, Dt.27-2-2017 for Rs.10,000/- ; 2) VUDA Receipt No.1098/2018-19, dated 13-6-2018 for Rs.79,016/- & 3) VUDA Receipt No. 1638/2018-19, dated 12-9-2018 for Rs.5,66,166/- towards processing fees, development charges and paper notification charges.

Accordingly, the applicant has submitted the layout plan duly demarcating the layout pattern on ground by cutting trenches along the roads and requested for release of approved layout plan.

The applicant has executed the deed of mortgage for the Plot Nos. 12,13,14 & 32 to 38 (10 plots) to an extent of of Acs.0.63 cts. to VUDA in Sy.Nos. 21/P,
