The General Manager, District Industries Centre, Visakhapatnam has forwarded the proposals for approval of plans for construction of in S.No.141 in Plot No. 6 of Gambheeram (V) Anandapuram (M) Visakhapatnam in extent 1921.50 Sq.Mtrs M/s Sri Sai Ganesh Enterprises under Single Window in the reference 1<sup>st</sup> cited.

Earlier, the VUDA has approved the APIIC Industrial Layout vide L.P.No.48/2008 in S.NO.140, 141, 142/1, 144/2, 145/2, 152/8, 154, 155/P, 245 & 246 of Gambheeram (V), Anandapuram (M), to an extent of Ac.94.40Cts. and released vide proceedings Rc.No.792/07/L4.

The applicant's site is vacant on ground. The above site is abutting to 40'-0" wide approach road.

Accordingly the applicant has paid total amount of Rs.42,129/- towards Processing fees and Development charges 1) VUDA receipt No.1701/2014, dated 28-07-2014, Rs.1,900/- 2) VUDA receipt No.2459/2014-15 dated 20-09-2014, Rs.40,229 /-

The plans so received have been examined in detail and found that the Industrial building plans satisfied all the norms as per the GO.MS.No.168 MA & UD (Dept.) dated 7-4-2012.
