**EXPRESSION OF INTEREST (EOI)**

For Engagement of Facility Managers on Outsourcing Basis for The Deck, Kailasagiri, Museums, Parks and Auditoriums.

**1. Background & Objective**

In view of the increasing public footfall, expansion of facilities, and growing revenue-generating activities at The Deck, Kailasagiri, VMRDA Museums, Parks and Auditoriums etc., VMRDA proposes to engage qualified Facility Managers on outsourcing basis to ensure professional, efficient, and technically sound management of its key public assets.

At present, the Revenue Section is coordinating multiple operational functions such as ticketing supervision, vendor management, cleanliness, utilities management, minor maintenance, safety compliance, grievance redressal, and coordination with outsourced service agencies. These functions are technical, continuous, and field-intensive, necessitating dedicated on-site supervision by trained professionals. The absence of specialized facility management support has resulted in operational inefficiencies, increased administrative burden, delays in resolution of issues, and potential revenue leakages.

The proposed engagement aims to strengthen operational efficiency, service quality, asset longevity, safety compliance, and revenue optimization, through deployment of technically qualified Facility Managers.

**2. Scope of Work**

The Facility Managers shall be responsible for, but not limited to, the following:

- Supervision and monitoring of day-to-day operations of outsourced services including housekeeping, security, electrical systems, lifts, landscaping, ropeway interface, and allied services.
- Ensuring compliance with Standard Operating Procedures (SOPs), safety standards, statutory norms, and Service Level Agreements (SLAs).
- Monitoring utilities consumption, preventive maintenance schedules, breakdown management, and asset lifecycle planning.
- Providing accurate operational reporting linked to revenue realization, supporting control of leakages and service quality enhancement.
- Acting as the nodal technical interface between Revenue Section, Engineering Wing, contractors, vendors, and service providers.


