Sri K. Narasimha Raju & others have submitted the proposals for approval of
layout for an extent of Ac 3.85 Cts in S. No. 174/1,2,4 to 9,10P, 175/2,3,5,7, 9 to 11 of
Cheepurupalli West (V) Parawada (M) Visakhapatnam District in the reference 1st
cited, above.

The plans so received have been examined in detail and the applicant has

The layout is under VK PCPIR SDA. The layout was included in the list of
pending layouts in VK PCPIR SDA area which was put to 2nd Board Meeting held on

process the layout for approval.

Accordingly the applicant has submitted the layout plan duly demarcating
the layout pattern on ground by cutting trenches along the roads and requested for
release of approved layout plan.
