Srinivasa Rao have submitted the proposals for approval of layout to an extent of Ac 24.31^{1/2} Cts in S.Nos.46p & 51p of Duppituru (V), Atchutapuram (M) Visakhapatnam District in the reference 1st cited above.

The plans so received have been examined in detail and the layout is conceived in an extent of Acs. 13.64 Cts with approach road of existing 40'-0" wide roads. The applicant has furnished land conversion of agricultural to Non-agricultural purpose orders issued by the competent authority, the R.D.O., at Narsipatnam vide D.Dis.No.76/2010/B dated 6-2-2010 for an extent of Ac 24.69^{1/2} cts. The applicant has paid total amount of Rs.22,68,269/- towards processing fee, development and paper notification charges vide Receipt Nos.1715/171413, dated 23-11-2009 Rs.10,000/- and VUDA IOB challan No.19156 dated 26-2-2010 Rs.22,58,269/- and Gram Panchayat charges of Rs.98,403/-.

The layout area is fallen under VK PCPIR SDA. The Zonal Manager, APIIC, Visakhapatnam has furnished the NOC for approval of layout. Accordingly, the applicant has submitted the layout plan duly demarcating the layout pattern on ground by cutting trenches along the roads and requested for release of approved layout plan.

The applicant has executed the deed of mortgage for the plot Nos.176, 185, 20 to 213, 228 to 237 & 245 to 272 (Total plot Nos.54) covering to an extent of Acs. 2.10 cts, in S.Nos.46/p & 51/p of Duppituru (V) Atchutapuram (M) Visakhapatnam District and got the same registered by Registration Department. The applicant has also been directed to execute indemnity Bond on 100/- Rupees non-Judicial stamp papers.

In the reference 7th cited the applicant has furnished Mortgage deed duly Mortgaging the plots in the Sub-Registrar office, Yelamanchili, Visakhapatnam vide document No.1497/2011 dated 6-4-2011 and also furnished the indemnity Bond to develop the layout. The applicant has also submitted the Photographs of Mortgaged plots which are fenced with barbed wire and also erected display Boards showing the details of plots Mortgaged to VUDA at the layout site and requested to release approved layout plan.

The matter has been examined in detail with reference to the provisions of A.P. Urban Areas Development Act, 1975 and also in accordance with the Statutory Master Plan / Zonal Development plans along with the existing G.O.s and Rules and Regulations which are in force. The layout is hereby approved in L.P.No.3/2011 of VK PCPIR SDA and communicated subject to the following conditions:

- 1. The layout owner is permitted to sell the plot Nos. 1 to 175, 177 to 184, 186 to 199, 214 to 227, 238 to 244 (Total 218 plots)
- 2. That the Layout now issued does not exempt the lands under reference from purview of Urban Land Ceiling Act, 1976 if any
- 3. This permission of developing the land shall not be used as proof of the title of the land.
- 4. The applicant shall solely be responsible for the development of the layout and in no way VUDA will take up development works.
- 5. The deed of mortgage executed by the applicant in favour of VUDA is purely a measure to ensure compliance of the conditions of development of infrastructure by the applicant/developer and VUDA is no way accountable to the plot purchaser in the event of default by the applicant/developer.
- 6. In case the applicant/developer fails to develop the layout area with the infrastructure facilities as specified by VUDA the area so mortgaged in favour of VUDA shall be forfeited and also VUDA to liable to take criminal action against such applicant/developer as per provisions of A.P.U.A. (D) Act, 1975.
- 7. The layout development work as per the specifications enclosed.
- 8. The layout applicant is directed to complete the above developmental works within a period of two years and submit a requisition letter for releasing of mortgage plots/area, which is in the favour of Vice-Chairman, VUDA duly enclosing letter in regard to roads, open spaces taken over by the Panchayat Secretary, Duppituru (V), Atchutapuram (M) Visakhapatnam District.

- 9. The applicant shall not be permitted to sell the plot Nos. plot Nos.176, 185, 200 to 213, 228 to 237 & 245 to 272 (Total plot Nos.54) and the Panchayat Secretary, Duppituru (V), Atchutapuram (M) Visakhapatnam District shall ensure that, no development like buildings authorizedly or unauthorizedly should come up in the mortgaged site.
 - 10. The applicant is permitted to sell the plots, other than mortgaged plots as mentioned in item No. 1 above.
 - 11. The Local Authority, shall not approve and release any building permission or allow any unauthorized developments in the area under Mortgage to VUDA in particular, and in other plots of the layout in general until and unless the applicant has completed the developmental works and then got released the mortgaged land from VUDA.
 - 12. The layout applicant shall display a board at a prominent place with size 10' X 10' in the above site showing the layout pattern with permit L.P.No.3/2011 of VK PCPIR SDA, dated 20-4-2011, S. No. & Village, extent of layout, No., plots, percentage of open space, intended for common amenities and with full details of the layout specifications and conditions to facilitate the public in the matter.
 - 13. The Panchayat Secretary, Duppituru (V), Atchutapuram (M) Visakhapatnam District should ensure that the open spaces shall be developed by the applicant along with other developments with ornamental compound wall as per the sanctioned layout plan.
 - 14. The Panchayat Secretary, Duppituru (V), Atchutapuram (M) Visakhapatnam District shall ensure that the area covered by roads and open spaces of the layout shall be taken over from the applicant, by way of registered Gift Deed, before release of Mortgage to the applicant, after collecting the necessary charges before release of Mortgage to the applicant as per their rules in force.
 - 15. The local Authority shall also ensure that the all the open spaces shown in the layout must be developed by the applicant with greenery along with play equipments for children and benches before it is taken over by the Panchayat Secretary, Duppituru (V), Atchutapuram (M) Visakhapatnam District.
 - 16. The developer shall form the 40'-0" wide roads as shown in the layout plan as per the standard specifications of VUDA.
 - 17. The applicant shall produce the register document for the approach road in front of all the mortgaged plots and sell the plots after submission of the registered document before releasing of mortgaged plots.

Two sets of Plans duly endorsed and authenticated are enclosed herewith. The Panchayat Secretary, Duppituru (V), Atchutapuram (M) Visakhapatnam District is requested to release one set of plans to the applicant and direct the applicant to abide by the conditions and develop the layout strictly adhere to the plan. Any deviation in this matter will be viewed seriously and action will be taken as per the provisions of the Act.
