ORDER:

In view of the revision of the Notified wages to the NMR Workers for the year 2006-07, the District Level Committee has met on 26-09-2006. The Committee members examined the Consumer Price Index communicated by the Labour Bureau, Ministry of Labour Govt. of India and the Gazette No 40,dt. 27-01-2005 issued by the Commissioner of Labour, Govt. of A.P., Hyderabad and came to a decision and fixed the rates shown in the statements appended, to the NMR workers for the year 2006-2007 applicable from 1-07-2006 to 30-06-2007. These rates are applicable to NMR workers employed in the departments under the Administrative control of Irrigation and Power, Panchayatraj, Public Health, Roads & Buildings and Electricity departments. These rates are also applicable to NMR workers engaged in all other departments and Govt. Institutions like Visakha Dairy, Indira Gandhi Zoological Park, Anti-Malaria department including the employees engaged in Steel Plant Malaria Unit, Visakhapatnam who do not attract the minimum wages fixed under the Minimum wages Act, 1948 by the Govt.

In respect of NMR workers, employees with in the limits of Visakhapatnam Municipal Corporation, Visakhapatnam an increase of 15% over the basic rates of notified wages shall be allowed, 10% increase in Municipality area and also 15% increase in Agency area over the basic rates of notified wages shall be allowed.






