

SUBJECT NO: 87.

Subject:- To sanction the extension of deputation of S/s. B.Rambabu, D.F.O, Ch.Veeresalingam, F.R.O and K.K.Farook, Forester for a further period of one more year and also sanction of posts for one more year.

AGENDA NOTE:

The Government have sanctioned the Post of Divisional Forest Officer in G.O.Ms. No. 276 M.A. dated. 11.06.1987 initially for a period of 1 year from the date of utilisation of the post subject to condition that the expenditure on the above shall be met from the funds of the Visakhapatnam Urban Development Authority. Accordingly the Chief Conservator of Forests, A.P., Hyderabad was requested to depute one suitable officer to the post of D.F.O. to work in Visakhapatnam Urban Development Authority initially for one year. As such Sri B.Rambabu, Asst. Conservator of Forests was posted to work as Divisional Forest Officer in Visakhapatnam Urban Development Authority in G.O.Rt. No. 1156, dated. 22-10-1986. He has reported to duty on 30-10-1986. Thus, the period of deputation of Sri B.Ram Babu will be expired by 29-10-1987. His services are still required for a further period of One more year beyond 29-10-1987, as the Visakhapatnam Urban Development Authority has got very ambitious programme of afforestation to the tune of 81.00 lakhs for the year 1987-88.

Further, Government have also sanctioned the following posts in G.O.Rt. No.973, M.A. dt.01-07-1986 to the Visakhapatnam Urban Development Authority, for utilisation initially for a period of one year from the date of utilisation of the posts.
