## AGENDAS

Sri Ashok Kumar Agarwal, Vapagunta, Visakhapatnam has applied for conversion of land use from Agricultural to Industrial use for installation of Saw Mills (139HP) in an extent of 8.795 Acs. in S.Nos.22p, 25p, and 26p of Lakshmipuram Village, Pendurthi Mandal.

The matter is examined in detail. He proposed vertical band Saw Mili machines 4 Nos. each 15HP, Herizontal band Saw Mill Machines 4 Nos. each 15 HP, grinding Machines 4 Nos. each 1 HP and Iron Roller type conveyor balt Motor 15 HP in the above factory. The applicant has furnished title dods, 10(1) Adangal particulars, M.R.O.Cortificate for non-involvement of Government land and also not effected under Agricultural Land caling Act.

The Planning Officials of VUOA have inspected the site. The applicant site is located on adjoining to Vepagunta - Rampuram (Junction) Read. As per sanctioned Master Plan, the site is earmarked for Agricultural use. The applicant's site is effected to a depth of 16%-6% io., about (0.06 cents) 290 Sq.yards under widening of proposed 100%-0% Master Plan Read. Site is situated within ½KM from the existing Lakshmipuram Village builtup. The proposed Saw Mill factory comes under category of non-harardous injustry. The applicant has already started construction of compound wall around the site and also shads, but Saw Mills and Generator have not been commenced. The Secretary, VUDA has informed on 17.6.2000 that the

The applicant has produced the letter of consent from General Manager, D.I.C., dated:27th June, 2000 for clearence from Prevention and Centrel of Pollution rules. This is treated as a consent of A.P.Pollution Centrel Board subject to certain conditions as per the delegation given to General Manager, D.I.S. for S.S.I. Unit by A.P.Pollution Board. The applicant has not paid the development charges of R.3,53,494/- towards conversion of land use from Agricultural to Industrial use.

In view of the above, the matter is placed before VUDA Board to recommand to Government for approval of the change of land use from Agricultural use to Light Industrial use for an extent of Ac.8.795 cts. in Survey Nos. 22p, 25p and 26p of Lakshmipuram Village, Pendurthi Mandal, Visakhapatnam for installation of Saw Mills (139 HP) subject to the following conftiens.

- 1) The applicant shall pay Davelopment charges of Re.3,53,494/- towards conversion of land use before sending the proposals to the Government.
- 2) The applicant should form the read fallen under widening in his site to a depth of 16'-6" and handover an extent of 290 Sq.yds. to the LocalMAuthority at the time of Building plan approvals.
- The applicant shall obtain Building Plans permission from the VUDA after change of land use from Agricultural use to Industrial use is approved by the Government.
- 4) The applicant should follow the conditions issued under the consent latter of General Manager, D.I.G. under rule 32 of the provention and central of Pollution.
