The District Collector, Visakhapatnam in his proceedings Rc.No.1963/2002/C7, Dt.21/06/2002 issued orders fixing the rates of minimum wages for the NMR's for the year 2002-2003. These rates of wages shall come into force with effect from 01/07/2002 and will be in force till 30/06/2002

The Orders issued by the District Collector, Visakhapatnam with regard to fixation of wages in respect of NMR's are being adopted and extended to the NMR's working in VUDA every year.
