The Vice-Chairman, VUDA welcomed the Hon'ble Chairman, VUDA and other Members of VUDA Board and requested the Hon'ble Chairman, VUDA to initiate the proceedings. The Board instructed the Vice-Chairman, VUDA to take up the agenda for discussion.

The Board perused the action taken report of the Minutes of the VUDA Board Meeting held on 03.05.2014. The Board resolved to approve the Action Taken Report with the following observations

- (1) As regards the Action Taken Report with reference to the Resolution No.29, the Board directed the Vice-Chairman, VUDA
  - To take legal opinion on zero date consideration of Development of Layout in S.No.563/1 (carved out from S.No.348) of Dakamarri on Joint Venture basis with M/s. Vensar Constructions Company Ltd., and also obtain the opinion of the Financial Consultant with regard to revenue sharing model.
  - Regarding alienation of the land to VUDA, the matter may be pursued with the Government.
  - In future, don't entertain the Joint Venture Project for plotted development.
