Sub:- VUDA- Visakhapatnam- Accounts- Widening of Anakapalli Main Road -
Payment of Compensation- Approval- Reg.

AGENDA NOTE

The District Collector, Visakhapatnam in his note dt 26.6.2005 has requested VUDA to reimburse Rs 1.00 Crore which was released towards compensation of demolished buildings during Road widening work taken by R&B Department at Anakapalli. The Municipal Commissioner, Anakapalli Municipality has requested to release the balance amount of Rs.2.74 Crores for payment of compensation to the affected people in the Road Widening of Anakapalli. As per the Hon'able Chief Minister assurance during his visit at Anakapalli during Rajeev Nagar Bata the infrastructure development works to a tune of Rs 5.00 Crores are considered to be taken up with VUDA funds only. Though, the value of development works taken up in Anakapalli Town is much more than the development charges received from the Anakapalli Region, VUDA has taken up the above works to fulfill the promises made by Hon'ble Chief Minister. Since release of funds towards compensation to the demolished buildings in addition to the infrastructure developmental works will be a major audit objection, the Government were addressed in this office letter dt 28.6.2005 that the VUDA is not in a position to release an amount of Rs 3.74 Crores towards payment of compensation as requested by District Collector.

But, the Government vide Memo No 14598/H2/2005-1 M.A, dt 12.7.2005, have directed the Vice Chairman, VUDA to pay the building compensation duly following the Rules for Road Widening work. Further the Government have also directed the District Collector, Visakhapatnam to take immediate action for allotment of land to VUDA.

Basing on the instructions of the Government and basing on the Note of the District Collector dt 26.6.2005 addressed to the Vice Chairman and an amount of Rs 1.00 Crore has been released for the above purpose and sent to the District Collector, Visakhapatnam and the balance amount of Rs 2.74 crores has been sent to the Commissioner, Anakapalli Municipality.


The District Collector, Visakhapatnam has been requested for allotment of land in Madhurawada, Vepagunta Villages with permission to auction the plots to realize the amounts already incurred by VUDA for infrastructure facilities at Vambay Housing Colony and development cost and compensation for road widening at Anakapalli.

The matter is placed before the VUDA Board for approval and ratification.

VUDA Resolution No.19, dated 16-12-2005
