Sub:- E.E - Zone-III - Construction of Minor Bridge across $80^{\prime}$ Road Connecting Lake View Layout and Midhilapuri Colony at Madhurawada - Draft Board subject - Submitted for Perusal and Ratification - Reg.

VUDA has taken up development of Lake View Layout in an extent of Ac. 29.70 cents in Governments land handed over by the District Administration at Madhurawada.

Along with development works of layout an earthen Road of $80^{\prime}$ wide was formed to connect Midhilapuri Layout and Lake Vicw Layout with the provision available in the project cost earlier. But the same could not be completed due to crossing of gedda across the road and land dispute arisen for part of the road.

Afterwards, A.P. Housing Corporation thas taken up ' VAMBAY' Housing Scheme to accommodate nearly 5000 units adjacent to Lake View Layout in the Gogernment land earmarked.

Keeping in view of the recent development of Vambay Housing Colony and proposed auction of left over plots in Lake View Layaout, it is felt that it is desirable to connect VUDA Midhilapuri Colony and Lake View Layout and Vambay Housing by completing the left over road by constructing a minor bridge across the gedda Accordingly an advertisement was also released in Newspaper on the day of auction and the same fetched a lot in getting as the bid amounts gone to very high.

In accordance with the above an estimate has been prepared to construct a Minor Bridge for Rs. 26.40 lakhs.

The Vice-chairman, VUDA has accorded Administrative Sanction for Rs. 26.40 lakhs on 16-12-2004. The tenders were invited and received on 31-12-2004 and the details of financial bids are as follows.
