Sub: Engg - Zone III - Formation of WBM Surface & BTSD to Madhurawada - Kapuluppada 100' wide Road (1st carriage way)- Draft Board Subject -Submitted to VUDA Board for perusal and ratification - Reg

VUDA has launched Mega Housing Project (2000 Residential Flats) in an extent of 40 Acres facing Madhurawada - Kapuluppada 100'0" wide road and proposals are made for taking up Group Housing Scheme in Kapuluppada Layout.

Taking into consideration of the future development in and around Madhurawada and Kapuluppada areas, Tourism potential to Thotlakonda and Bavikonda Buddhist Heritage center and development of Housing Schemes like VAMBAY, Rajiv Gruhakalpa and residential colonies in the vicinity, it is proposed to develop a wide corridor in the shape of 100' wide road connecting NH - 5 at Jathara point and Bheemili Beach road near Timmapuram.

Accordingly it is proposed to take up providing WBM and BTSD for one carriageway of Madhurawada - Kapuluppada 100' wide road in 1st Phase with an estimated cost of Rs.324Lakhs.

Salient Features:

Total length of the Road : 5.90Km

Width of the Carriage Way : 7.50M (single carriageway)

Construction of CC drain on one side : 5.90Km

Construction of CD & Protection works: 5 Pipe culverts +1 Slab Culvert

The Vice Chairman VUDA accorded administrative sanction for Rs.324Lakhs for the subject work on 16-3-2005.

The tenders were invited in two-cover system stipulating Eligibility Criteria as per G.O No. 94 of I&CAD Department and received on 13-04-2005.


The Hon'ble Chief Minister of A.P has laid the Foundation Stone for this project on 11-05-05.
