Sub: VUDA – Revenue section – Ratification of action taken for consideration of certain grievances submitted by MGM Diamond Beach Resorts (P) Ltd. – Regarding. @ @ @

The VUDA in its Resolution No. 552 dated 11-7-2000 has approved the recommendations of the committee in considering MGM Diamond Beach Resorts (P) Ltd for allotment of 8 Acs of land in VUDA park on lease basis for 9 years at a licence fee of Rs. 18.00 lakhs per annum with the following conditions.

The MGM Diamond Beach Resorts (P) Ltd has paid the security deposit of Rs. 18.00 lakhs and furnished a Bank guarantee for two months rent of Rs. 36.00 lakhs and executed a licencee deed.

The MGM Diamond Beach Resorts (P) Ltd has requested in their letter dated 3-6-2006 for consideration of the following grievances duly stating that they have started the operation of the park on 16-5-2003 even though the land was handed over to them on 8-11-2000.

- To postpone the enhancement of licencee fee at 33% for 3 years for the period from 2003-2006.
- 2) To reduce the interest for the period from 24% to 8%.
- 3) To permit them to pay the annual licencee fee in monthly installments.
- For waival of penal interest pending as on date i.e. 31-3-06.

Not to encash the Bank guarantee given by them.

- 6) To reduce the enhancement of licence fee from 33% to 10%.
- 7) NOC for open-air drive in theatre.
- To reduce the annual licence fee from Rs. 18.00 lakhs to Rs. 10.00 lakhs.

The matter has been examined in detail and a Committee has been constituted with all HODs and LO for finalization of the grievances of M/s.M.G.M. Diamond Beach Resorts (P) Ltd. After submission of a report by the Committee, the following grievances have been considered.

- It is not considered for postponement of enhancement of annual licencee fee at 33% for 3 years for the period 2003-2006.
- It is not considered to reduce the penal interest from 24% to 8% but it is agreed to reduce the same to 12%.
- It is not considered for payment of annual fee in monthly installment basis but it is agreed to pay the same in advance quarterly.
- 4) It is agreed for waival of penal interest as on date i.e. 31-3 2006 which works out to Rs. 48,454/-.
- 5) It is agreed not to encash the bank gurantee subject to condition that they should pay the dues by 31-7-06 failing which, the bank guarantee will be encashed.
- 6) It is agreed to reduce the enhancement of licencee fee from33% for 3 years to 7% every year instead of 33% to 10%.
- 7) The request for grant of NOC for an open-air drive in theatre is agreed subject to obtaining of all the necessary clearances.
- 8) It is not agreed to reduce the annual licencee fee from Rs.
 18.00 lakhs to Rs. 10.00 lakhs as it is a settled issue.

The matter is therefore placed before VUDA Board for ratification.
