SUB:- Establishment – VUDA – VSP - Regularization of services and declaration of Probation of certain Executive Engineers – Reg.

The VUDA has taken up many mega projects like Vizag IT park, Sailing Cruises, Visakha-Bheemili beach Road, Simhachalam hill top road, Senior Citizen user friendly residence (Sagar Nagar), Akkireddipalem, Vadhanudi, Rushilonda & Madurawada mega housing projects, Rope Way, Toy tra etc., during the year 2004. For speedy implementation and completion of the works, it is necessitated to strengthen the Engineering wing by increasing the staff like E.Es.

The budget proposals approved for the year 2004-2005 and the expenditure proposed on works is to a tune of Rs. 85.42 crores during the year 2004-2005.

It is considered that there is every need to create additional posts of Executive Engineers in additions to the existing divisions. Accordingly the following individuals have been promoted as Executive Engineers on 29.01.04 and 01.10.04 as detailed below considering their experience in various works.

The up gradation proposals have been approved by the VUDA Board previously i.e., on 24.02.04. But the same was not sent to Government previously for necessary ratification.

At present 8 E.Es are working, Out of them 7 are borne employees and one E.E on Deputation. Out of 7 born E.Es, one Sri. G.V.G.S Murthy, EE has recently taken Voluntary Retirement. So totally 6 born employees are now working. As per VUDA service rules approved by Government in GO.Ms.No: 560 MA, Dt: 29.06.1982, no procedure with regard to up gradation of posts


At present, the VUDA has taken up Mega Housing Projects and also Mega Shopping Complexes, Implementation of Master Plan Roads and there is every need to continue the above E.Es to complete the works within a target time.

All the promoted E.Es have already reached the scale of pay of Executive Engineers and they have completed more than 13 to 18 years of services in the cadre of Dy. E.Es and also been sanctioned Special Adhoc Promotion post scale. There is no financial burden to the organization for giving promotion to the individuals since they have reached the scale of pay in the cadre of .EEs.

In view of all the above, the matter is placed before the VUDA board for ratification the action in promoting the above individuals as Executive Engineers .by upgrading the Dy.E.E.Posts. Necessary proposals will be sent to Government for ratification of the action taken in promoting the above individuals duly declaring their probations and regularizing their services as Executive Engineers.
