AGENDA NOTE:

Earlier proposals were submitted for construction of VUDA Guest house and Senior Citizen Centre in the Plot No. G(which is vacant) measuring an extent of 1600 Sq Yds of Kirlampudi Layout in Sy.No.982/P & 983/P. VUDA Board vide its Resolution No.20, Dt.30-7-2010 (Ref- 1) approved the above.

Thereafter as per the orders of then Vice-Chairman, VUDA and based on the plans/drawings communicated by OSD,(PMU) vide U.O. Note Rc.No.5643/10/PMU, Dt. 20-09-2010 Engineering wing has prepared an estimate for Rs.560.00 Lakhs. The Vice-Chairman, VUDA accorded Administrative sanction for Rs.560.00 Lakhs and permitted to take up the work on 20-9-2010 (Ref-2).

The Hon'ble Chief Minister, Government of Andhra Pradesh, Dr. K. Rosaiah has laid the foundation stone for this project on 26-09-2010.

Later during the review of development works taken up by VUDA, Chairman and Principal Secretary to Government, MA & UD Dept.,, District Collector, Visakhapatnam and other officials, it is felt that it is not desirable to take up Senior Citizen Centre and VUDA Guest House in the site keeping in view of the high commercial value and strategic location of the site. It was also opined that it is better to take up Mini Planetarium and Science Centre Project in this site as the same ideally suits for this purpose and helps to promote Tourism Industry as it is located opposite to Kursura Submarine Museum maintained by VUDA.

On enquiry with the technocrats and experts in the field of establishing planetarium in Mumbai and Bangalore, it was informed that the site is suitable for establishment of Planetarium and Science Centre and the tentative project cost would be around Rs.20.00 Crores.

On submitting the proposals of establishment of Mini Planetarium and to cancel the earlier proposals of VUDA Guest House and Senior Citizen Centre, the VUDA Board vide its Resolution No. 18, Dt.08-05-2012 (Ref – 4) resolved that the the Vice Chairman, VUDA to identify the alternative land for the Senior Citizens Centre and put up in the next Board Meeting. But the same could not be placed before the subsequent VUDA Board Meetings since the identification of alternate land has not finalized.

It is further submitted that, the proposal for establishment of Science Centre near Kapualuppada VUDA Layout was sent by District Collector as per the instructions of Hon'ble Minister and MP, Visakhapatnam Dr. D. Purandeswari during review of development works taken up in Visakhapatnam City. In the above proposal, the component of establishment of Mini Planetarium was also included. The same is under process and it may take some more time for necessary approval from Gol. The site selected for establishment of Science Centre is at Kapualuppada which is located at a distance 20 Km from the city.

As the matter stood thus the representation of Sri Jaya Narayana Kureti, Chief Promoter of M/s. Jaan Entertainment (P) Ltd., Vijayawada, Dt.20-09-2013 (Ref - 5) addressed to Hon'ble Chief Minister to allot the land on lease basis for a period of 33 years and the total outlay of the project would be around Rs.10.00 Crores was received from the Hon'ble Chief Minister's Office with a direction to examine the allotment of land for establishment of Family Entertainment Centre in the above site.

In view of the above, it is submitted that a decision may be taken for suitable utilization of the land either considering the location's importance, sea view and commercial value.

Hence, the matter is placed before VUDA Board for perusal and taking decision.
