Apart from the above, it is further to submit that the NTPC has entrusted the deposit work for Rs.3,82,71,310/- under Green Visakha Plantation Programme for Afforestation purpose of 70,000 Nos for Raising of Barren hills in the various allotted locations i.e., Rushikonda – 20,000 Nos, Bavikonda – 15,000 Nos and Gollakonda – 20,000 Nos and other suitable areas for 15,000 Nos. accordingly the Vice-Chairman, VUDA has been pleased to accord Administrative Sanction for Rs.3,82,71,310/- and the work is progress.

As the matter stood thus, the General Manager, NTPC has also requested for Raising of 30,000 No. of saplings for its plantation in the allotted areas through VUDA. Accordingly an estimate has been prepared for Rs.1,40,98,625/- during the year 2013-14 and requested to release the funds to VUDA so as to take up the work on Tender basis.
