## **AGENDA NOTE:-**

It is to submit that, the contract workers working in various parks and sites of VUDA are being engaged through the Petty Contract System, under the control of the Forest Range Officer – I & II of UFD wing, VUDA for doing cleaning, gardening and plantation works as detailed below for kind perusal.

It is further submitted that, the daily wage workers have represented to the Vice-Chairman, VUDA, Visakhapatnam about the enhancement of wages as per the revised rates fixed by the District Collector, Visakhapatnam. At present the wage rates are being paid at Rs. 205.12 per day which comes to at Rs. 6153.84 per month. This rate is being adopted since 01-07-2012 in the estimates.

VUDA Board has approved the proposal for enhancement of wages to workers @ 10% over the existing wages vide Resolution No. 111 dated 30-7-2010.

Further on the similar lines, the Vice-Chairman, VUDA has sanctioned the enhancement of wages in the year 2011-12 & 2012-13 as follows:-

The District Collector, Visakhapatnam in Progs D. Dis. No. 1966/2011/C7, dt.9-1-2013 has issued Prodgs enhancing the rates of daily wage workers applicable w.e.f 1-7-2012 and this will be in force up to 30-6-2013 as per the statement appended there to (copy as the same is also enclosed herewith for kind perusal).

It is further submitted that, the details of payment of daily wage workers and comparison with the wage rates of District Collector, Visakhapatnam and as per SSR 2012-13 (unskilled) are as follows:-

In view of the above, the following two proposals are worked out for enhancing the wage rates of daily wage workers:-

- Proposal A:- If the District Collector's approved wage rate allowed to them (2013-14) @ Rs.315.00 Per day. Worked out to Rs.9450.00 per month to each worker.
- Proposal B:- If 20% is increased on the existing VUDA wage rate, it comes to Rs.246.15 per day @ Rs.7384.50 Per month to each worker.

Hence this matter is placed before VUDA Board to take suitable decision on above proposal.
