## **AGENDA NOTE:-**

It is to submit that, VUVDA has developed Jogging and Cycle tracks at VUDA Health Arena at Foot Hills of Kailasagiri to a total length of 2.10 Kms. Towards development of landscape gardening, Avenue plantation, Herbs & Shrubs, palms, bamboo etc., to cover an area of approx 900 mtrs in Phase – II, the following landscaping and Afforestation works are being proposed.

It is submitted that, towards Development of Greenery and Landscaping along the Jogging Track phase – I at Kailasagiri foot hills estimates for Rs.50.00 Lakhs sanction was accorded / approved by VUDA Board (vide resolution no. 62 dt.8-5-2012) and works completed.

An amount of Rs.50.00 Lakhs is estimated towards landscaping and greenery of Health Arena (Jogging and cycle track) phase – II. Accordingly Administrative sanction accorded for Rs.46.74 Lakhs to take up the above said works from the budget allocation provided for Rs.190.00 Lakhs towards development works at Health Arena under Budget Code No.4-B-80.

The above works in Phase – II are attended and completed up to 90% and the balance 10% work is in progress. The subject was placed before the VUDA Board held on 20-07-2013 for kind perusal and ratification. However, the Board Resolved that "Due to model code of conduct of 4th ordinary Elections to the Gram Panchayats, the subject item is postponed for the next meeting".
