**Sub:- VUDA – UFD – Landscape gardening at Telugu Samkruthika Niketanam at Kailasa hills with an estimated amount of Rs.30.00 Lakhs – Draft subject placed before VUDA Board – Perusal and approval – Reg.**

**AGENDA NOTE:-**

It is to submit that, at Kailasagiri hills a prestigious project namely “Telugu Samskrutika Niketanam” was established with an outlay of 9.00 Crores by VUDA at International standards during the year 2012-13 with an objective to popularize the Telugu Samsukruti in India as well as at Abroad, as it will be a unique centre for Telugu people from all over the world.

In view of the above for beautification of the surroundings, it is proposed to develop the landscape gardening and greenery works in the premises of Telugu Samskutika Niketanam i.e., Development of Lawns, Flowering Herbs & Shrubs, Avenue plantation erection of topiaries depicting Telugu culture, planting creepers and providing drip and sprinkler irrigation system etc. For that, it is estimated that an amount of Rs.30.00 Lakhs is required for development of the above said works. Accordingly, the budget allocation by VUDA towards Landscaping at “Telugu Samskrutika Niketanam” for the year 2013-14 is Rs.30.00 Lakhs (vide function no. 4-B-104 is earmarked).

Further it is submitted that, Plantation of Avenue species in side and on approach road including parking areas were completed with 450 Nos tall trees. Further Landscaping has to be initiated in coordination with the project Architect M/s. Oscar and WTF members.

The above subject has been placed before the VUDA Board held on 20-07-2013 for kind perusal and ratification. However the Board Resolved that “due to model code of conduct of 4<sup>th</sup> ordinary Elections to the Gram Panchayats, the item is postponed for the next meeting”.

In view of the above, the subject is placed before VUDA Board for kind perusal and approval to take up plantation and landscape works at Telugu Samskutika Niketanam on Kailasagiri.
