AGENDA NOTE:-

Urban Forestry Wing in VUDA looks after the Avenue, Greenery and landscaping such as VUDA assets (Parks), Environmental Improvement schemes like Haritha Visakha, Avenue Plantation in VUDA Schemes Greenery in VMR Area, Beautification of Master Plan Roads, Development of New Parks, Maintenance of Nurseries and certain deposit works entrusted by other Government Agencies.

The Budget of Forest Wing, VUDA for the year 2013-14 is as follows:

All the works are presently being executed through Petty contract system under the close supervision of Forest Range Officers as per the Technical Sanction accorded by the Divisional Forest Officer with sanction of estimates up to Rs.10.00 lakhs and below.

However, for certain few works tenders were invited in last five years as follows.

- 1) Division Forest Officer (1No) -on deputation from Forest Department/Horticulture Department in the cadre of Deputy Director.
- 2) Forest Range Officers (2 Nos) FRO (1 No) from Forest Dept and Horticulture Officer (1 No) from department of Horticulture.
- 3) Tech persons (3 Nos) on outsourcing basis.
- 4) Administrative officer (1 No) with supported ministerial staff
- I) In regard to execution of works by the DFO's & FRO's of Forest Departments the "Manual of instructions" on Forest works, specifies the following powers and delegations to the Officer's with procedure on "Method of execution" of works etc.
- 1) Power for sanction of Estimates.
 - a) CF Rs.20.00 Lakhs
 - b) DFO Rs.10.00 Lakhs
 - c) FRO Rs. 0.50 Lakhs
- 2) Method of execution of works.
 - a) Piece work contract method- Generally to be followed, when the value work is not more than Rs.1.00 lakh.
 - b) Lump Sum contract method This system should be followed, when value of work is more than Rs.1.00 Lakhs (Major works).
 - c) Nomination of contractors for minor works This Nomination system should generally be for works costing not more than Rs.1.00 Lakh.
- 3) Delegation for entrustment of works on nomination.
 - a) CF Rs. 5.00 Lakhs
 - b) DFO Rs.3.00 Lakhs
 - c) FRO Rs. 0.50 Lakhs
- 4) Delegation of powers for entering into contractors.
 - a) CF Rs. 20.00 Lakhs
 - b) DFO Rs.10.00 Lakhs
 - c) FRO Rs. 0.50 Lakhs

5) Delegation of powers for acceptance of tenders.

- a) PCCF 15% Excess of the estimated value of the work put to tender
- b) CF 10% Excess of the estimated value of the work put to tender
- c) DFO 5% Excess of the estimated value of the work put to tender

Agreement for Nomination works can be concluded either in the form of piece work agreement or in the form of lump sum contract agreement, depending on classification of work as either minor or major.

- II) In view of the above, it is submitted before the VUDA Board to take a policy decision on
 - a) Execution of all Development / Nursery / Maintenance works costing more than Rs.1.00 lakh and above through competitive tender procedure except certain works wherever it is not feasible.
 - b) Petty works, works of urgent nature and other emergency works shall be taken up either through Departmental execution (or) Petty Contract System.
 - c) Procurement and maintenance of Tools and Equipment through stores maintained at Nursery.
 - d) All Technical Sanctions and Agreements upto Rs.10.00 lakhs shall be dealt by the DFO, VUDA.
 - e) Estimates more than Rs.10.00 lakhs all Technical Sanctions and Agreements shall be routed through Chief Engineer, VUDA, as Chief Engineer in VUDA was delegated with powers of Chief Engineer for Sanction of Estimates, Concluding Agreements.
 - f) Evaluation of tenders more than Rs.50.00 lakhs, a Tender Committee shall be constituted as per the procedure as deem fit on the Similar lines of Engineering tenders.

Hence, the above policy decisions from (a to f) above are submitted before the Board for favour of kind perusal and approval.
