AGENDA NOTE

The Government vide G.O Ms No 14 G.A (Ser.Wel) Department dt 16.01.1995, have issued orders regarding reimbursement of Bus fares to the Government employees as follows 1/3 of the cost is to be born by the Employee and 2/3 of the cost is to be born by the Department / Government.

The VUDA employees are also being allowed the facility of Bus pass reimbursement from time to time The Bus pass reimbursement is being paid from the cadre of LGS/ SD Man/ Sr.Asst.

Recently the Divisional Manager, APSRTC, Visakhapatnam has informed in his letter cited that the Monthly Bus pass tickets have been enhanced with effect from 06.11.2013 and the details of cost of Bus Pass and reimbursable amount to the eligible employees as on date are as follows.
