AGENDA NOTE

Sri Kasa Appa Rao, AEE VUDA in his representation dt 25.06.2013 has stated that he got injured (spine nerves and legs) on sudden collapse of FF roof slab on 17.6.2013 at YSR Park. He stated that he was admitted in KGH immediately for first aid purpose and subsequently admitted in Seven Hills Hospital and in turn to APEX Hospital for better treatment and he got operated to his spine and post operation treatment is in process and he has requested to grant medical expenses towards his treatment.

The C.E VUDA in his report dt 29.03.2013 reported that while casting the first floor (roof) slab of Administration block and Ticket Counter including the central passage at Dr.YSR-VUDA Central park, entire slab was collapsed all of a sudden at 3.00 PM on 17.06.2013. The C.E VUDA has requested to release medical expenses as per eligibility in accordance with rules in force.

Sri Kasa Appa Rao, AEE VUDA vide his representation dt 10.07.2013 has requested for reimbursement of medical expenses incurred during treatment of his injury and also enclosed Emergency Certificate & Essentiality Certificate, I.P Discharge certificate along with medical bills for Rs.1,80,000/- (Rupees one lakh eighty thousand only). He has also claimed Rs.21,131/- towards his First Aid Treatment in Seven Hills Hospital on 17.06.2013 & 18.06.2013 vide his representation dt 08.08.2013.

As per the GO.MS.No.74 Health Medical and Family welfare (K1) Department dt 15.03.2005, the employee or his dependants are entitled for reimbursement of medical expenses for treatment of all road accident cases under emergency conditions in the unrecognized private hospitals to save the life of the patient and in such cases the claim can be considered for reimbursement up to a limit of Rs.25,000/- and the HODs are authorized to sanction the claim up to Rs.25,000/after getting the scrutiny of bills. In respect of claims over and above Rs.25,000/- it shall be refereed to the concerned administrative department in Secretariat for obtaining relaxation of rules. The Government vide GO Ms No 68 Health, medical & Family Welfare (K1) Department dt 28.03.2011 vide point No 2(j) recommended deletion of the word "road" occurring in para 9(9) of GO Ms No 74, medical & Family Welfare (K1) Department dt 15.03.2005.

With reference to A.P Integrated Medical Attendance Rules in Go Ms No 105 dt 09.04.2007, the State Government employees are entitled for reimbursement of medical expenses up to a maximum ceiling limit of Rs.2.00 lakhs for the major aliments like bye pass heart surgery, kidney transplantation etc..., for the treatment obtained from recognized hospitals and also for the treatment obtained from NIMS, Hyderabad or SVIMS, Tirupathi or actual cost which ever is less.

In this connection it is submitted that the VUDA has framed separate Medical Rules to their employees i.e.., payment of one month Basic Pay in 4(four) quarterly installments in a year and the same was adopted Vide Resolution No.113 dt28.09.2003. Accordingly, the VUDA staff are being paid medical reimbursement on quarterly basis. It is also submitted that the services of Sri Kasa Appa Rao were regularized and he was joined in the cadre of AEE on 09.05.2013 as per the proceedings Rc No 1696/78/A3/A1 dt 12.06.2013 and the individual has not claimed any medical reimbursement / assistance so far.

There are some precedent cases where medical reimbursement was made as per Government G.Os though the concerned individuals were covered under VUDA medical rules which was ratified by Hon'ble VUDA Board. The details of some of the precedent cases are as follows.

Under these circumstances it is submitted that Sri Kasa Appa Rao, AEE was injured while on duty and hence, the request of the applicant was considered on humanitarian grounds for sanction of Rs. 2,00,000/- towards reimbursement of medical expenses (i.e.., expenses of Rs.1,80,000/- incurred in APEX Hospital and Rs.20,000/- incurred in Seven Hills Hospital).

The matter is placed before VUDA Board for ratification of reimbursement of medical expenses of Rs. 2.00 Lakhs to Sri K.Appa Rao, AEE VUDA
