## **AGENDA NOTE:**

VUDA developed many Layouts - Sites & Services / Plotted development schemes and Group Housing Projects in its jurisdiction at various places in the past. The required infrastructure facilities i.e. formation of roads, construction of CD works, Storm Water Drains, Providing Water Supply Distribution, Layout Electrification, Development of Parks and Avenue plantation were provided in almost all the layout and Housing Schemes.

In spite of the above, certain infrastructure facilities like water supply and layout electrification are yet to be completed in some of the layouts / housing projects completed in the recent past due to various reasons. Moreover in certain layouts, though water supply arrangements and layout electrification were completed certain important items like sluice valves, motors, spindles, manhole covers conductor of electrical lines and distribution transformers were stolen due to thefts in the layouts located in remote areas because of lack of development and poor occupancy. In addition infrastructure facilities are not provided in full shape for certain layouts developed in Government lands in the recent times.

As such, the Allottees / Plot owners in different layouts developed in the past at various locations are now approaching VUDA to complete the balance / left over infrastructure facilities since they are not in a position to construct buildings and to reside there. Further being a development authority, it is mandatory for VUDA to provide necessary infrastructure facilities for the layouts / housing projects taken up by VUDA in full shape before handing over of the same to the local body or GVMC for further maintenance. In view of the above, it is felt that it is desirable to complete the balance / left over infrastructure works pending in the layouts developed earlier and recent times to fulfil the requirements in the layouts / housing projects as per the commitment of VUDA and to keep the credibility in public.

Accordingly, line estimates were prepared towards completion of infrastructure works wherever required in the layouts / housing projects developed by VUDA as per the instructions of Higher Authorities. The total estimate cost based on the SoR for the year 2012-2013 is worked out to Rs.2600.00 Lakhs and following are the abstract details:
