## **AGENDA NOTE:**

VUDA has constructed Nine (9) No of shops in Ground Floor at Pitapuram Colony, during the construction of the colony (30 years ago), in the site earmarked for commercial. Earlier, a decision was taken to demolish the old Shopping Complex and to construct a Modern Complex at the above vacant site, during the Board Meeting, dated.15.09.2011. After dismantling the old shops now VUDA has a vacant Commercial Site admeasuring 931.89 sq.mtrs at Pitapuram Housing Colony abutting the National Highway Service Road.

Conceptual Plans for the proposed Complex have been prepared by the Planning Wing, VUDA for Construction of Commercial Complex with Cellar Floor for Parking, Ground Floor for Shops and Parking, First Floor to Fifth Floor for office space with Plinth Area of each floor consisting of 545 sq.mtrs. The proposed floor area details are as follows.

Cellar Floor parking area
 Ground Floor Shops Area
 First Floor to Fifth Floor for office area (418 Sq.mtrs x 5 Floors)
 490 Sq.mtrs
 150 Sq.mtrs
 2090 Sq.mtrs

Total Build up Area (545 sq.mtrs X 7 Floors) - 3666 Sq.mtrs

As per the Conceptual Designs furnished, the tentative Project Cost is arrived for the proposed Commercial Complex on Plinth Area estimate basis and the Project Cost worked out is as follows.
