AGENDA NOTE:

It is submitted that government lands to an extent of Ac.6192.48 cts was handed over to VUDA for various purposes. Out of that extent, alienation proposals to an extent of Ac.3921.73 cts were submitted to the District Collector, Visakhapatnam which are under process at different stages from the District Collector to the Chief Commissioner of Land Administration, A.P., Hyderabad. Alienation proposals are yet to be submitted to the balance extent of Ac.2274.75 cts. to the District Collector, Visakhapatnam. The Vice-Chairman, VUDA has directed to verify and confirm the same with the information available in the records of the Collector's Office, Visakhapatnam such as, proposals submitted to the District Collector from this office and the proposals submitted by the District Collector to Chief Commissioner of Land Administration, A.P., Hyderabad etc. A statement showing the details of the land for which alienation proposals were submitted and for which the proposals are yet to be submitted from VUDA is submitted below for favour of perusal. It is also submitted that reconciliation of the above proposals is being taken up with the available records of the Collector's Office, Visakhapatnam to arrive at a correct position of the same and to take further course of action in this regard.
