Sub: VUDA - Visakhapatnam - Estt. - Compassionate appointments to the dependents of the deceased employees of VUDA - Reg.

AGENDA NOTE:

It is to submit that the legal heirs of the deceased VUDA Employees have applied for appointment on compassionate grounds as their spouses / parents have expired while in service in VUDA.

In this connection it is to submit that the Government in their letter No.20332/B1/2000-3 MA ,dt.21-11-2001 have issued orders discontinuing the scheme of compassionate appointments in Urban Development Authorities in the state as it is liberalized form and be confined to the Government employees only. As such, Between 2001 to 2009, no compassionate appointments were made in Visakhapatnam Urban Development Authority too.

Later, Government have issued orders vide G.O.Ms.No. 19, dated 7-1-2009 of MA & UD Department, restoring the compassionate appointment scheme to the legal heirs of deceased employees of all the Urban Development Authorities in the state on par with the state Government employees. In pursuance of the above orders, 13 appointments were made to various category of posts based on the qualifications / eligibility on compassionate grounds between the year 2010 to 2011 in VUDA as their spouses / parents have expired while in service during the period between 2001 to 2011.

After the above appointments, still 17 eligible applications were pending for appointment under compassionate grounds, but VUDA is unable to accommodate due to the reason that there are no sufficient vacancies presently available in the cadre of Attender / Chainmen as the applicants are eligible only for the post of Attender / Chainmen as per the VUDA staff Recruitment and Service Regulations.

In view of the above, the matter is placed before the VUDA board meeting held on 15-12-2012 to authorize the Vice Chairman to fill up the vacant posts under compassionate grounds against the vacant posts created by Government and VUDA Board. The Board discussed the matter and resolved to send a detailed proposal to Government.

In pursuance of the Board Resolution No.114, dt. 15-12-2012, a detailed report sent to the Government vide this office Letter R.C.No,8554/2008/A1 dated.7-3-2013 informing that the available vacant post in the cadre of Junior Assistant will be filled as per VUDA Recruitment and Service Regulations under compassionate appointments as permitted by the Government. It is further requested to accord permission to the Vice Chairman, VUDA to fill up the posts under compassionate grounds by creation of supernumerary posts in the cadre of Attender / Chainmen accommodate the legal heirs of deceased employees of VUDA under compassionate grounds.

In response to the detailed report submitted to the Government, the Government in their letter No.6227/B1/2013-1, dt.15-7-2013 of MA & UD department had requested the Vice Chairman, VUDA to take further necessary action for providing appointments on compassionate grounds to the legal heirs of the deceased employees of VUDA from the existing vacancies of Junior Assistant / Chainman / Attender, subject to availability of Direct Recruitment vacancy. In pursuance to the above orders, 3 appointments one each as Driver, Sweeper, watchman were made based on the qualifications / eligibility on compassionate grounds against the regular DR vacancy.

Further at present still 16 (14 remaining applicants + 2 deaths reported in 2013) eligible applications were pending for appointment under compassionate grounds, but the VUDA is unable to accommodate due to the reason that there are no sufficient vacancies presently available in the cadre of Attender / Chainmen as they are eligible only for the post of Attender / Chainmen as per the VUDA staff Recruitment and Service Regulations.

At present the following are the details of the eligible applications pending for appointments on compassionate grounds who are the legal heirs of the deceased employees of the VUDA.

VUDA is ready to bear the additional financial burden from its own resources. Further there is every need to fill up the posts as VUDA is facing dearth of staff due to the expansion of VUDA's Jurisdiction.

Hence, the matter is placed before the VUDA Board for approval and kind directions in this regard.
