## **AGENDA NOTE:**

Vide reference 1<sup>st</sup> read above, disciplinary action has been initiated against Sri.R.Nageswara Rao, Administrative officer by framing charges in connection with non recovery of an amount of Rs.48,74,700/- from Sri.P.Ranga Rao, License of Kilasagiri toll gate. Smt.R.J. Vidyulatha, Chief Urban planner was appointed as inquiry officer vide reference 2<sup>nd</sup> read above to enquire into the charges leveled against .R.Nageswara Rao, Administrative officer.

Vide reference 3<sup>rd</sup> read above, Smt.R.J. Vidyulatha, Chief Urban planner & inquiry officer has submitted the inquiry report stating that out 4 charges, 2 charges are held proved against the individual. The Disciplinary authority i.e. Vice Chairman has been pleased to serve a memo to the delinquent officer duly enclosing a copy of the inquiry officer's report for his response.

In response to this office memo vide reference 5<sup>th</sup> read above, Sri.R.Nageswara Rao, has submitted his response vide reference 6<sup>th</sup> read above stating that he made numerous efforts and endeavors to recover the monthly license fee, but the said Sri.P.Ranga Rao ,Licensee was once upon a time a VUDA Board Member and he could not able to take up coercive steps. Further he requested to kindly look into the matter and waive objective consideration to the facts and circumstances on purely humanitarian grounds with a view to extend courtesy towards him who is going to retire from service on superannuation on 30-6-2013.

On examination of the inquiry officer's report and delinquent officer's explanation, the disciplinary authority i.e. Vice Chairman had imposed the punishment of "stoppage of one annual increment without cumulative effect for a period of one year", as the charges are held proved.

Aggrieved with the orders of the Disciplinary Authority, Sri.R.Nageswara Rao, retired Administrative officer, VUDA has preferred an appeal against the punishment awarded to him and stated that "the license fee amount was due from a VUDA Board member and so many times I have approached him and reminded him to remit the due amounts. He went on saying that, it would remit it within a week. Thus delay has taken place. I submit that I am having a large family and it has to be taken care of only on my pensionory benefits alone. I retired from public service on superannuation on 30-6-2013 due to the benevolent gesture of yours. I am never involved in any financial embezzlement in the department and I have always discharged my duties with the utmost satisfaction of my superiors from beginning to retirement" and requested to reconsider his case and drop the punishment on mercy grounds of awarding withholding one increment without cumulative effect.

Hence the matter is placed before the VUDA board for kind perusal and for giving necessary decision in this regard.
