AGENDA NOTE:

VUDA has promoted "VUDA Children's Club" as part of the VUDA Children World (upcoming VUDA Children Arena) as an exclusive platform for children and conducting various activities for personality development and good citizenship training programmes, apart from cultural events. Weekend classes in drawing, classical and folk dances, magic and other leisure activities, screening of children oriented films on every Sunday, conduct of Summer Camps for kids and other activities form part of the VUDA Children's Club programmes.

VUDA Children's Day event is the main activity conducted by VUDA every year during the month of November. The event has become one of the biggest happening not only in Visakhapatnam but also at the Regional level and State Level during recent years. Weeklong celebrations with various competitions to children are the prime activity of the celebrations. Children from various government, private and corporate schools, dance & music institutions and NGOs are taking part in the competitions every year.

Children from Visakhapatnam, Vizianagaram, Srikakulam and East Godavari districts including Itchapuram, Rajahmundry, Kakinada and other places are participating in the competitions. The number has been increasing year by year. There is tremendous response from children, parents, school managements as well as general public for the VUDA Children's Day celebrations and the event has been earning good image and reputation for the Organization.
