## **AGENDA NOTE:**

It is to submit that Vice-Chairman, VUDA has accorded Administrative sanction for certain works during the period 2008 - 2013. But the works could not be grounded due to various reasons and the same are pending till now.

In addition, proposals were submitted for taking up certain works before VUDA Board during the meeting held on 15-12-2012. Even though same were agreed in principle by VUDA Board, some of the works could not be taken up in reality for want of certain clearances and approvals.

In view of the above, the details of works for which administrative sanction was accorded but not taken up and proposals agreed in principle by VUDA Board and yet to be taken up along with the reasons are mentioned hereunder.
