**AGENDA NOTE:**

Hon'ble MLA, Vizianagaram Sri P.Ashok Gajapathi Raju and Hon'ble MLC Sri K.Veerabhadra Swami, Vizianagaram have requested VUDA vide their letters in the references cited above to construct a minor bridge in Poolbagh colony as the existing bridge reached to dilapidated condition causing much difficulty to the public and posing threat of collapse and occurrence of accidents. Thereupon, the site was inspected and observed that it is essential to reconstruct the bridge to cater the needs of public as it is an important road connectivity for the people residing in Poolbagh area in Vizianagaram. Since the above work comes under infrastructure development and Vizianagaram area is covered in the VMR region of VUDA, the request deserves consideration.

Accordingly, an estimate was prepared for construction of minor bridge considering the field particulars and based on the standard type designs. The span of the bridge is 8.00 Mts (single vent) and the height of the bridge is 3.00 Mts. The estimate has been worked out to Rs.57.00 Lakhs based on the SoR for the year 2012-2013 including all statutory provisions. The actual structural design has to be made before commencement of the work by conducting soil investigation through authorized academic institution.

The Vice-Chairman, VUDA has accorded Administrative Sanction for the subject work for Rs.57.00 Lakhs on 24-10-2013 and permitted to take up the work by way of e-Tenders. The tenders are invited for the subject work and will be received on 27-11-2013.

Hence, the subject matter is placed before VUDA Board for approval and ratification.
