AGENDA NOTE:

A New Rythu Bazaar with 173 stalls was constructed by VUDA during the year 2007 in an extent of 1.13 Ac. adjacent to the existing Rythu Bazaar in M.V.P.Colony, Visakhapatnam with a proposal to shift the existing Rythu Bazaar to the new premises and to construct a Mall and Multiplex on BOT basis in the existing Rythu Bazaar site based on the importance of the site of existing Rythu Bazaar in a prime location. The construction of New Rythu Bazaar was completed in September-2007 with a cost of Rs.55.00 Lakhs. The shifting of the existing Rythu Bazaar is not yet materialized due to political and public oppositions and the matter is under correspondence with the Marketing Department and the District Administration.

In the meanwhile since the premises of New Rythu Bazaar is vacant without any activity, it is being allotted to various Government and Non Government agencies for conduct of Exhibitions on daily license fee at the following rates during the past years.
