1.	10/68	Sri B. Narasimhulu, Ramakrishnapuram.	Permission for the conversion of roof and construction of first floor over it may be refused since it falls in the road widening portion of the G.N.T. Road.
2.	12/68	Sri B. Narasimha Rao Allipur ward.	Permission for the construction of the terraced building may be recommended.
3.	16/68	Sri R. Apparao, Allipur Ward.	Permission for the construction of the out house may be recommended.
4.	1/68	Sri N. Pydiah	Permission for the construction of the terraced building may be recommended.
5.	4/68	Sri G. Sanyasi Naidu Allipur.	Permission for the construction of the tiled out house may be recommended.
6.	15/68	Smt. P. Agnammma, Allipur.	Permission for the construction of the terraced building may be refused as it is in violation of size open space and poor open space.
7.	9/68	Sri B. Kanakayya, Venkojipalem.	Permission may be refused, since there is no approved layout to this area.
8.	11/68	Sri P.S. Sriranga Chari, Allipur.	Permission for the extension of Kitchen in the ground floor and construction of the first floor may be recommended, subject to the construction of staircase on the eastern side.
9.	14/68	Sri S.K. Dawood Marripalem.	Permission for the construction of the terraced building and tiled out house may be recommended.

10. 7/68 Smt. P. Venkayyamma Permission for the construction of the terraced building may be recommended.
11. 5/68 Smt. K. Appayyamma, Allipur. Permission may be refused since there is no approved layout and sub division.
12. 13/68 M/s. Shree Auto Centre, Market Ward. Permission for the Petrol Bank may be recommended.
13. 489/68 Sri I. Chinna Rao, Bette plan/not in conformity with the approved layout. Permission for the construction of the terraced building in the rear space/Violation of rule 8(a) may be refused.
14. 35/68 Sri S.S.R. Sastry Allipur. Permission for the construction of a first floor building may be granted as it satisfied building rules and scheme provisions.
15. 30/68 M/s. Vizag Bottling & Co. Industrial Estate. Permission for the construction of A.C. sheet shed for the erection of gold spot bottling factory within the industrial estate compound may be granted.
16. 34/GR Sri Kapadia, Venkojipalem The proposed construction of A.C. Sheet shed falls within the widening portion and building line of G.T. Road (Shimilipainam Road). Hence permission may be refused.
17. 24/68 Sri P.K. Subba Rao Kapparada. Permission for the construction of a shed for the erection of 1C H.P. Elec. Line. mortar crusher may be granted as it is within the non-residential area.
