Sub:- Establishment - VUDA - Further continuation
of certain posts in Forest Wing - Reg.

AGENDA NOTE:

The Government in G.O. Rt. No. 452, M.A., Dt. 18-4-94 have accorded sanction for continuation of the following posts in Urban Forestry Division, VUDA upto 28-2-95.

D.F.O ..1 Post, F.R.Os .. 2 posts & Foresters.. 3 posts.

In pursuance of VUDA Board Resolutions No. 673, Dated. 26-9-94, and Resolution No. 4, Dated. 22-9-97 the Government have been requested from time to time for continuation of all the above posts upto 28-2-2000. The sanction sought for from the Government for these posts will expire by 29-2-2000.

The Government in letter No. 26283/B1/99-1 M.A.,Dt.25-1-2000 have informed that in G.O.Ms. No. 202, Finance & Planning (F.W.B.G.) Department, Dated. 14-12-99 orders were issued extending the time for further continuation of temporary posts under non-plan upto 29-2-2000.

The Government in G.O.Ms. No. 274, Municipal Administration & Urban Development (1-2) Department, Dated. 23-5-89 have approved the Master Plan of VUDA subject to the condition that the Authority should undertake extensive planting of trees in area specifically set a part in the Master Plan as "Green Belts".

As per the Master Plan 593.62 Acres of area earmarked for recreational open spaces and for Green belts. The Government of Andhra Pradesh is very particular about clean and Green and allotted target of 25.00 lakhs nursery seedlings during 1999-2000. Approximately Rs.25.00 lakhs worth maintenance works like maintenance of Avenues which were already planted by VUDA, including the maintenance of VUDA Park and Kailasagiri Park besides nursery maintenance. These works are regularly maintained in every year.

VUDA is also planning to prepare a project on "Securing external aid to afforestation and to create green belt in and around city and suburban areas under the control of VUDA and Forest Department. To extend aid to implement the greening of areas in collaboration with Forest Department for preparation such project and also implement of the subject is approved, continuation of Urban Forestry Division is essential. Urban Forestry Division is required in VUDA since VUDA is taking up

plantation in various layouts. Further the maintenance of VUDA Park and Kailasagiri required expertise.

In view of all the above facts, it is felt that continuation of Urban Forestry Division in VUDA is essential for further period of 5 years. Hence the Government were requested to accord sanction for continuation of all the posts in Urban Forestry Division, VUDA for further period of 5 years from 1-3-2000 to 28-2-2005 vide this Office Letter Rc.No. 1108/86 A1, Dated. 7-2-2000.

Hence the matter is placed before VUDA Board for approval and ratification of the action taken in addressing the Government for continuation of Urban Forestry Division in VUDA upto 28-2-2005.
