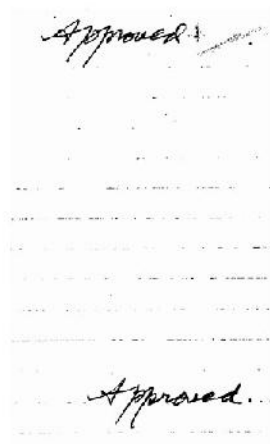
Read office note stating that the negotiated tender dt. 25-1-68 of M/s. G.S. Raju & Co., at 4.88% above the estimated rates is the lowest.
