AGENDA NOTE :

The V.U.D.A. is taking up major Housing Schemes viz. Infrastructure Development Works under Sites & Services Scheme and other Projects, including Bridging the Gap of providing crucial infrastructure in the Visakhapatnam Metro Region. V.U.D.A. is also taking up Deposit Works and Tourism Works at the behest of user Agencies.

Presently the Engineering Wing of V.U.D.A. is headed by the Superintending Engineer with Chief Engineer powers and also Executive Engineers and Dy. Executive Engineers as supporting staff.

At present, the Superintending Engineer, who is exercising Chief Engineer powers, is burdened heavily with all the estimates referred for according Technical Sanction, inviting Tenders and processing tender procedure etc. This is causing avoidable administrative delay and work load concentrated at one place warranting decentralization of Technical powers at various levels.

Existing powers (Technical) being exercised by the Engineering officials are as follows :

For speedy execution of works and to streamline the work load the following powers are delegated as ordered below :

1) ADMINISTRATIVE SANCTION :

The Dy.E.E. to initiate every proposal through the Executive Engineer and Chief Engineer for obtaining Administrative Sanction from the Vice-Chairman, VUDA.

2) TECHNICAL SANCTION :

All the Dy.E.Es. are delegated with the Executive Engineer powers i.e. according Technical Sanction up to Rs.10.00 lakhs, inviting and processing tenders.

The Executive Engineers and also the Dy. Executive Engineers, who are kept F.A.C. of Executive Engineer post, are delegated the powers of Superintending Engineer to accord Technical Sanction up to Rs.50.00 lakhs inviting and processing tender procedure.

Sri R.G. Krishna Reddy, Executive Engineer on deputation from Public Health Department shall exclusively in charge of Vizianagaram Town Development Works contemplated from time to time and exercise the Technical Powers and functions in terms of P.H. Engineering Department norms over and above his competency, he shall approach the Superintending Engineer of V.U.D.A. and obtain technical sanction for the proposed works. However, he should continue to obtain Administrative Sanction for the works relating to Town Development Committee headed by the District Collector, Vizianagaram, as specified already.

The following territorial Jurisdiction among the Executive Engineers is ordered :

All works relating to Vizianagaram Town Development Committee as part of P.H. Engineering Department Plans.

The present practice of Measurement, Check Measurement and Test Check will be continued as it is with respect to A.E./A.E.Es./Dy.E.Es. and Executive Engineers in terms of Codal Rules.

On going works presently under control and supervision of the Dy.,E.Es. functioning as Executive Engineer (F.A.C.) and by the Executive Engineers concerned continued to be supervised and monitored by them until the works are concluded finally notwithstanding the revised orders issued now for the Administrative convenience.

The Dy. Executive Engineers/Executive Engineers (FAC) and Executive Engineers are competent to process the Part Bills to the extent of their Technical competency direct to the Chief Accounts Officer, for payment.

The procedure followed in Visakhapatnam Municipal Corporation in inviting tenders scrutiny and approval of tenders, concluding agreement at Executive Engineers level shall be followed in respect of V.U.D.A. Works for the works beyond their Technical competency with the prior approval of the Chief Engineer, VUDA.

The Chief Engineer, shall be supported by a Steno/Typist and all other technical staff working presently in his office shall be distributed by the Chief Engineer, among the Divisions at his end. Resultantly, one of the Dy.E.Es. presently designated as P.A. to the Chief Engineer will be repatriated to his original post.

All the Final Bills will be sent through the Chief Engineer, (Superintending Engineer cadre) to the Chief Accounts Officer for scrutiny and payment.

The matter is placed before V.U.D.A. Board for post approval.
