V.U.D.A. has called for "Allotment of site for Amusement / Educational Park' vide paper notification dated. 28-10-98. In response to this, 1) Applications were received. These applications were not finalised at the time of receipt and kept pending: 2 applicants have taken back their E.M.D.

On scrutiny of applications received, it was noticed that as no prescribed format was fixed, the data given by the applicants was not comparable and in-conclusive. For evaluation, it was felt necessary that certain details are to be common and certain terms and conditions are to be stipulated. Accordingly the format was finalised listing out the terms and conditions. 3 Agencies who kept their E.M.Ds with VUDA along with the applications were infirmed of terms and conditions. The salient points in the terms and conditions are -

- (a) Extent: 3 Acres 'As is where condition'
- (b) For VUDA Park VIDA, SADA & CRZ Clearances for permanent structures to be obtained.
- (c) For Kailash Hill Prior permission of Government.
- (d) Lease period 9 years with 33% enhancement for every 3 years.
- (e) Security deposit 1 year rent, Bank Guarantee. From rent and requested to give their revised offers (on 14-2-2000). Initially time has been given 15-3-2000 and also offer extended upto 11-4-2000. Inresponse to this, 4 previous applicants have resubmitted their offers.
