## AGENDA NOTE:

Sri G.Sundara Rao, S/D'man in his application dt. 14.6.2004 stated that while returning from outdoor duties on 19.4.2002 he met with an accident at Maddilapalem and his left leg was fractured and seriously injured. As the matter stood thus, his kidneys were failed and doctors suggested to undergo renal transplantation which costs nearly Rs. 2,50,000/-. Added to this further expenditure he requires regular homodiolysis, which costs around Rs.15,000/- to Rs. 20,000/- per month. He has submitted the medical certificate from the respective doctor to that effect.

The matter has been examined in terms of G.O. Ms. No.58 Health, Medical and Finance Department (K1) dt.1.3.2002. According to which the Government employees are eligible for sanction of Rs. 1.00 lakh for treatment of bye-pass surgery, Kidney transplantation, Cancer and Neuro surgery only. The decease of the above individual comes under the category of Kidney transplantation which is eligible for medical re-imbursement as per rules.

In case of treatment in the recognized private hospitals, there will be a cut of 20% on the eligible amount vide G.O. Ms. No.175 dt. 29.5.97. The individual was admitted in the Apollo Hospital which is a recognized hospital. Hence, the individual was sanctioned Rs. 0.80 lakhs duly deducting the 20% on the eligible amount of Rs. 1.00 lakh.

In view of the above, the matter is placed before the Special Officer, VUDA for ratification of the action taken by the Vice Chairman.

Subject: - Widening of the existing B. T. Road from Kapuluppada Junction to Thimmapuram Junction to Beach Road - Administrative Sanction accorded - Work taken up with estimate rates - Reg.

VUDA has developed Satellite Township in Kapuluppada Layout with all infrastructure facilities. The layout consists of 1300 plots and all the plots were auctioned for public. The approach connecting Thimmaguram on Beach side and layout was connected with a Village Road with carriage way width of 3.66 Mtrs only. During development of the layout VUDA has provided W. B. M. Surface and B. T.S. D. for this road also and there is the only main approach for the layout. This proposed widened road is also main approach to the Bavikonda which is Buddhist Tourism Centre.

Recently, VUDA has proposed Chief Minister's Model Township development ie., Mega Housing Project at Madnurawada. This road is leading to the above project. Hence it is proposed to form earthen road by cutting levelling the existing land profile with earth work excavation by machinery by proclainers, J. C. Bs etc.,

It is proposed to widen the existing road to 100' Wide formation road with Central Divider. The proposal is made keeping in view of quantum of development activity to be taken place and vehicular traffic near future. Hence an estimate has been prepared and the details are as follows:

1. Length of the Road

: 2400 Mtrs.

Present estimate proposed for a length of 1700 Mtrs : From Kapuluppada

3. Carriage way

: 7 Mtrs. on both side

4. Central media

: 1.50 Mtrs

5. Side berms

: 2 to 3 Mtrs. on hill side 1.00 Mtr. to 1.50Mtrs. on

road side.

6. The average width of the road varies from 19 Mtrs. to 21 Mtrs.

The work entrusted to the contractors M/s. Venkateswara & company, Visakhapatnam who were experienced in Road works and having good equipment machinery ie., 200 capacity Proclainer, 100 capacity J.C. Bs, Dozers, Vibro Rollers, No. of Tippers to execute the work at estimate rates. The matter was placed before Sub-Committee on 28-2-2004.

Subject:- Providing infrastr facilities for newly carved out plots at Baba Metta Layout –

Administrative Sanction accorded and Approval of Tender – Reg.

VUDA has developed Baba Metta Layout in two phases earlier. Recently 22 numbers of new L.I.G plots are carved out in the vacant land available at entrance of the layout and the same are proposed for allotment by way of auction. The estimate cost towards infrastructure facilities i.e., formation of WBM Roads, Construction of C.D. Works & Drains and Water Supply facilities is worked out to Rs. 10.00 Lakhs and it is proposed to meet the above expenditure from the sale proceeds of the plots.

The Vice- Chairman accorded the Administrative Sanction for Rs. 10.00 Lakhs and permitted to take up the work through empanelled contractors.

Accordingly the tenders were invited and received from the empanelled contractors selected for the execution infrastructure development works and the details are as follows:

M/S Ramkey Infrastructure Ltd. 4.00% Excess

2. M/S Mechon Engineers & Contractors. 0.36% Less

M/S R.P.C Engineering Co.
 2.50% Excess

Out of the above, the tender of M/s Mechon Engineers & Contractors is the lowest i.e., at 0.36% less than the estimate rates working out to Rs. 8,97,356/- against the Estimate contract value of Rs. 9,99,598/- and the same was recommended for approval.

The Chairman and Vice - chairman approved the lowest tender.

VUDA proposed to take up "SECURE Project" for housing Senior Citizens. The project cost is Rs 245.00 Lakhs, (infrastructure, "A" type 8 Nos & "C" type 19 Nos, land landscaping, electrification etc.,) out of which the civil work value proposed for tendering is Rs. 147.78 Lakhs.

Paper notification has been issued for empanelment / entrustment of contractors and tenders received from 2 eligible agencies. The lowest tenderer is M/s Maruthi Engineering Co., at 7.9% excess, after negotiations with both the agencies who have tendered. The negotiated tender of M/s Maruthi Engineering Co., at 7.9% excess over the estimated rates amounting to Rs 159.45 Lakhs was recommended for approval taking into account the increase in rate of steel, Cement & Sand and non conventional works for roof.

The VUDA Board sub committee at its meeting on 03-04-2004 perused the tender recommended for approval. The then Chairman of VUDA also approved the tender proposal. Accordingly the agreement was concluded and works taken up.

Hence the matter is placed before the Special Officer, VUDA for ratification of the approval accorded.
