The VUDA has taken up Group Housing Scheme at Chinamushidiwada and the wok is nearing completion stage. Now it is proposed to provide Infrastructure facilities like 'Formation of Quarry Rubbish WBM and BTSD(Hot Mix) Construction of S.W.Drains and C.D.works and providing water supply facilities at Chinamushidiwada Housing Scheme Layout.

The Vice-chairman has accorded the Administrative Sanction for Rs.106.27 lakhs and permitted to take up the work through empanelled contractors.

Accordingly tenders were invited and received from the empanelled contractors selected for the execution of infrastructure development works and the details are as follows:

#### Subject No: 2 20

Sub: works- Engg. -VUDA-Hill top Road-Proposals for land Acquisition of the entrance of Hill Top Road-Regarding.

VUDA has taken up and completed the formation of Hill Top Road connecting NH-5 at Hannumnthawaka Junction and Simhachalam Temple along the ridge of Simhachalam Hill range. Adjacent to this newly formed Ghat road, there is a piece of land measuring to an extent of 1.5 Acres (approximately) abutting NH-5 and the same was fenced by certain private persons.

Keeping in view of the strategic location of the land and suitability for usage of the same for providing parking and other facilities for the tourists and visitors travel on Hill Top Road it is opined that it is desirable to acquire this portion of land. Accordingly proposals made for land acquisition.

This subject matter was put before the sub committee for perusal and approval during the sub committee meeting held on 8.5.2004.

The matter is placed before Special Officer VUDA for perusal and ratification.

Subject No: 221

Sub: Works - Engineering - VUDA - Simhachalam Hill Top Road - Accident on 13.02.2004 - Payment of exgratia for the diseased and injured persons -Perusal and ratification - Regarding.

VUDA has taken up the formation of Hill Top Road on Simhachalam Hill Range connecting NH5 at Hanumanthawaka junction and Simhachalam temple. As the work is at completion stage, an accident was occurred on this road on 13.02.2004 in which 11 persons were died and 8 others injured. The injured persons were admitted to the K.G.H and later they were discharged form the hospital. The Honorable Chairman, VUDA and District Administration responded immediately and rushed to spot and visited the Hospital to see the victims. After ascertaining the situation announced a compensation of an amount of Rs.1.00Lakh to legal heirs of diseased person and Rs.10, 000 to the injured person as compensation from VUDA.

The following are the details of payments to be made to victims from VUDA side.

- 1. For the Diseased persons' legal heirs 11 X 1.00 = Rs.11.00Lakhs
- For the Injured persons

 $8 \times 0.10 = Rs. 0.80 Lakhs$ 

Total

Rs.11.80Lakhs

As against the announced amount of Rs.11.80Lakhs an amount of 11.80Lakhs was given to R.D.O, Visakhapatnam in two spells on 17.02.2004 & 26.04.2004 (Rs.2.12Lakhs & Rs.9.68Lakhs.)

Accordingly sanction was obtained for release of payment of compensation from VUDA.

The same was perused and approved by the Sub Committee during the meeting held on Dt. 8.5.2004.

Subject No: 222

Sub: Works - Engg- VUDA - Simhachalam Hill Top Road - Certain Additional Works Taken up - Perusal and Ratification-Regarding.

VUDA has taken up the formation of Hill Top Road connecting NH5 at Hanumanthawaka junction and Simhachalam temple along the ridge of the Simhachalam Hill range. This road is proposed not only as an alternative route to Simhachalam but also to reduce the travel distance.

Earlier only earthen formation was taken up and completed for a length of 11.60 km. In the second phase it is proposed to take up W.B.M surface and Black topping on the existing earthen road. While commencing the road it is felt that it is desirable to obtain the expert opinion regarding gradients and curves from the competent authority so as to make it suitable for plying of buses as the existing gradients are steeper and curves are narrow at certain stretches.

Accordingly CRRI(Central Road Research Institute, New Delhi) was consulted for technical suggestions for the improvement of gradients and curves.

The CRRI Team inspected the Hill Top Road and suggested the following:

- 1. To provide drain all along the foot of the hill.
- 2. To provide C.D works at every 100mts interval.
- 3. To improve the stretches in which the gradients are steeper so as to maintain minimum of 1 In 10 by way of cutting / filling according to the ground position.
- 4. To widen the curves where the width of the road is narrow and inadequate.
- 5. To provide pueca drain at chain age 8.80km where water is oozing.
- 6. To improve the alignment from chainage 0.00 to 1.50 km by widening the existing steep curves and to ease the gradient.
- 7. To make alternate alignment from chainage 5.80km to avoid 'S' curve and steep gradient.
- 8. To Provide CC pavement at curves.

In accordance with the above proposals are worked out to a tune of Rs.70.324 Lakhs and sanction was obtained. Permission was also accorded to take up the said additional works, as the same were not covered in the original agreement.

The same was perused and approved by the Sub Committee during the meeting held on dt 28.02.2004

The matter is placed before Special Officer for perusal and ratification.
