The District Collector, Visakhapatnam in the Proceedings D.Dis No.1486/2007/C7, Dt: 1-12-2007 has communicated the notified wages of the NMR workers in the District for the year 2007-2008, and the details of wages fixed by the District Collector, Visakhapatnam are as hereunder.
