Sub: Works – Engg. – VUDA – Renovation of Tuna processing plant at NIFPHATT, Vizag Unit – Administrative Sanction accorded – Tenders accepted – Works taken up Draft subject placed before VUDA Board for perusal and ratification – Reg.

AGENDA NOTE:

VUDA has taken up Renovation of Chilled Tuna Processing Plant of NIFPHATT (National Institute of Fisheries Post Harvest Technology and Training Vizag Unit as deposit work based on the request of Director, NIFPHATT Cochin vide Ur. No. 1 FP work/1-29/2007-08, Dt: 18-10-2008 of NIFPHATT.

While accepting the above proposal, Director, NIFPHATT was informed that 10% Centage charges on estimated cost has to be paid to VUDA and 50% of estimated amount to be deposited as an advance before Commencement of the work.

Accordingly an estimate has been prepared as per the requirements furnished by NIFPHATT for Rs. 120.00 Lakhs based on the common SSR of all Engineering Department of Andhra Pradesh for the year 2008-09 and local rates prevailing in the market for the items not covered in the SSR.

The following are the details of works proposed :

1. Renovation of Tuna processing Plant at National Institute of Fisheries post harvest Technology & Training (NIFPHATT) at Vizag. (Civil Works)
Rs. 54.50 Lakhs.
 2. Construction of Retail Counter & Security Room at National Institute of Fisheries Post Harvest Technology & Training of Vizag.
Rs. 6.50 Lakhs.
 3. Supply and erection of Chill Room Panels, Refrigeration system, Lighting, Electrical Part & Generators etc.

NIFPHATT has paid an amount of Rs. 60.00 Lakhs to VUDA initially and agreed to pay the balance amount on completion of 50% of the total work.

The Vice Chairman VUDA has accorded Administrative Sanction for Rs. 120.00 Lakhs and permitted to take up works by way of e-procurement tenders.
