AGENDA NOTE

In view of proposed visit of Hon'ble Chief Minister of Andhra Pradesh to Visakhapatnam District on 25<sup>th</sup> to 26<sup>th</sup> November, 2009, District Collector vide letter Rc. No. 3351/2009/A5 dt. 17.11.2009 has requested the Vice Chairman, VUDA to consider the feasibility of providing necessary funds to take up the renovation of work of Government Circuit House (Known as Governor's Bungalow) being an old construction and a monument of archeological importance as there is dire need to execute urgent repairs and to renovate the same to accommodate VVIPs.

Accordingly an estimate for Rs. 11.43 lakhs proposed by Executive Engineer, APEWIDC, Visakhapatnam is enclosed for renovation of Government Circuit House. Since Government Circuit House is covered under "Heritage Buildings listed out in the VUDA VMR Master Plan 2021 approved by Government and VUDA has empowered to preserve and take up keep of the Heritage Building as per VUDA Act the request of the District Collector is considered and Vice Chairman VUDA has accorded sanction for Rs. 11.43 lakhs and permitted to release the amount in favour of District Collector, Visakhapatnam on 18.11.2009.

Subsequently, District Collector, Visakhapatnam has requested vide letter Rc. No. 3351/2009/A5 dt. 1.1.2010 to sanction an additional amount of Rs. 2.25 lakhs towards Electrical Cable and POP ceiling to complete the renovation work over the earlier estimated amount of Rs. 11.43 lakhs. Thus the total amount works out to Rs. 11.43 lakhs + Rs. 2.25 lakhs = Rs. 13.68 lakhs.

Being the additional work is also apart of the renovation work taken up previously, the request of the District Collector, Visakhapatnam has considered and Vice Chairman, VUDA accorded administrative sanction for Rs. 2.25 lakhs again and permitted to release the same to District Collector, Visakhapatnam.

The total amount of Rs. 13.68 lakhs (Rs. 11.43 lakhs + Rs. 2.25 lakhs) has been released as Contribution from VUDA in two spells to District Collector, Visakhapatnam.

Hence, the matter is placed before VUDA Board for kind perusal and ratification.
