Sri 8.Vishnu Murthy, Senior Asistant, VUDA has requested to sonation medical reimbursement as per the Government letter or payment of medical reimbursement on par with the VUDA Employees with effect from 01.12.2004.

In this connection, it is submitted that Sri B.Vishnu Murty, Senior Assistant, VUDA has undergone Kidney Transplantation Operation in the year 1995 for acute renal failure. He was sanctioned Rs. 50,000/ as medical aid and. Rs. 50,000/- as discretionary advance, which was recovered from the individual.

The Government in their letter, No. 10829/B1/99-1. MA. d.t. of medicines to him after obtaining necessary essentiality conflicted and medical bits from the individual upto the period which are required for post renal transplantation which are essential for recovery of the kidney transplantation operation on humanitarian grounds as a special case from VUDA funds.

The individual was paid medical re-imbursement @ Rs. 4.474/from 15.4.1998 to 30.11.2002 vide VUDA Board Resolution No. 60 dt. 29.03.1998 towards cost of medicines.

His case was referred to medical Board K.G.H on 21.09.2002 regarding his health status and bosing on the report of the Board he was given Medical reimbursement up to 2500/- per month towards 50% of the cost medical experies from 01.05.2004 to 31.07.2004, 01.09.2004 to 30.11.2004 and 01.03.2005 to 31.08.2005. Again he was referred to Regional medical Boards K.G.H for report on his Health status. The Medical Boards has gained to continue medicines and needs periodic evaluation and assessment. Basing on the medical report and as per Board Resolution No. 95 at 31.05.2006 he was sanctioned Medical reimbursement as a last one 88x.2500/- per month towards 50% cost of medical expenses from 01.04.2006 to 30.11.06 Subsequently he was not paid medical expenses with effect from 01.12.2004.

The individual had again requested for sanction of medical reimbusement on 12.11.2007, the matter has been placed before VIDA Board for sanction of Rs. 2000/- per month as medical reimbusement towards the cost of medicines and the resolution of the Board is availed.

Now he was requested for sanction of medical reimbursement on par with regular employees with effect from 01.12.2004.

In this connection it is submitted that the VUDA employees are being paid medical expenses on self declaration at one month basic pay payable in four quarterly installments as per the VUDA employees medical rules, which were trained as per the direction of Government and approved by Board vide Resolution No. 22 dt 06.12 2005. But the individual is not allowed medical reimbursement like other VUDA employees and now he is also not being sanctioned medical reimbursement basing on the essentiality certificate and medical bits as a special case as permitted by the Government.

In view of above, circumstance and after careful examination, the Vice Chairman has been pleased and approved the request of the individual for reimbursement of medical allowance on par with the other Employees of VUDA.

Hence the matter is placed before VUDA Board for perusal and ratification of the action taken by the Vice Chairman.
