AGENDA NOTE:

Earlier VUDA has proposed to take up development and widening of Master Plan Roads in Madhurawada area to open up new areas and diversify the population growth in Visakhapatnam City based on the request of local MLA's. These Master Plan Roads cater the future needs and provide better connectivity in between National Highway and Bheemili Beach Road and other areas.

Initially, 7 Nos. of Master Plan Roads of total length 19.10KM were proposed to take up is with an estimated cost of Rs.44.50 Crores. This proposal was approved vide VUDA Board Resolution No.29, Dt:08-05-2012.

Further GVMC Authorities were requested to clear the encroachments duly resolving the Private Properties issues and to furnish Road Development Plans (RDP) for Master Plan Roads within the GVMC limits so that VUDA can take up the execution of works without any hindrance.

Later, three more Master Plan Roads were taken up considering the importance and necessity for connectivity from NH-5 and Beach Road in Madhurawada area as per the request of Hon'ble MLA, Bheemili and GVMC Authorities. The present status of Master Plan Roads proposed, taken and completed and to be completed is noted below:

So far, 3 Nos. of Master Plan Roads taken up for a length of 7.25KM have been completed with an estimated cost of Rs.18.14 Crores.

Presently, 3 Nos. of Master Plan Roads are in progress for a length of 3.30KM at an estimated cost of Rs.12.64 Crores. Tenders invited for 3 Nos. of roads of length 6.00KM at an estimated cost of Rs.19.80 Crores.

Hence the matter is placed before VUDA Board for perusal and approval.
