## **AGENDA NOTE**

Sri B.Vishnumurty, A.O in his re-presentation dt 06.02.2013 has informed that he has undergone kidney transplantation operation 1st time on 30.08.1995 and now his Nephrologist has advised him to undergo kidney transplantation operation for the 2nd time as the function of kidney was exhausted. He has also informed that the estimated expenditure for the operation & post operation medicines will be approximately Rs. 11.90 lakhs. Hence he has requested to kindly consider for sanction of medical aid of Rs. 3.00 lakh & Discretionary advance of Rs.5.00 lakhs on humanitarian grounds.

The individual is having left over service of 8 years and the individual is drawing a gross salary of Rs.27,342/- and net salary of Rs.18,639/-.

The request of the individual regarding sanction of discretionary advance has been examined. Previously also, there are cases where discretionary advance was sanctioned to VUDA employees keeping in view of their financial status towards their medical treatment. The details are as follows:

Now basing on the representation of Sri B.Vishnumurty, AO and keeping in view of the seriousness of his ailment and expenditure to be incurred, an amount of Rs.3.00 lakhs has been sanctioned to the individual towards discretionary advance. The advance carries interest @ 8.50%. The recovery of advance will be commenced with effect from 06/2013 onwards (after his joining to duty).

As per A.P Integrated Medical Attendance Rules vide Go Ms No 105 dt 09.04.2007, the State Government employees are entitled for maximum ceiling limit of Rs.2.00 lakhs for the major aliments like bye pass heart surgery, kidney transplantation etc..., for the treatment obtained from recognized hospitals and also for the treatment obtained from NIMS, Hyderabad or SVIMS, Tirupathi or actual cost whichever is less. Besides this reimbursement facility in respect of major aliments, the Government employees are entitled for reimbursement of monthly medical expenditure basing on the essentiality certificate.

In this connection it is submitted that the VUDA has framed separate Medical Rules to their employees i.e., payment of one month Basic Pay in 4(four) quarterly installments in a year and the same was adopted Vide Resolution No.113 at 28.09.2003. Accordingly, the VUDA staff are being paid medical reimbursement on quarterly basis. The individual is also being paid one month basic pay in 4 quarterly installments every year with effect from 01.12.2006 towards medical reimbursement every year.

There are some precedent cases in this organization where medical reimbursement was made as per Government G.Os & as per VUDA Board Resolution. The details of some of the precedent cases where medical reimbursement is made is as follows.

Keeping in view of his financial position and also in view of costly treatment involved, the request of the individual has been considered on humanitarian grounds for sanction of medical reimbursement as per GO Ms No 105 Health medical & Family Welfare (K1) Department dt 09.04.2007 and an amount of Rs.2.00 lakhs has been sanctioned on production of medical bills.

The matter is placed before VUDA Board for approval and ratification for payment of discretionary advance of Rs.3.00 lakhs and medical reimbursement of Rs.2.00 lakhs in favour Sri B.Vishnumurty,AO for his kidney transplantation.
