**Sub:- VUDA – UFD – Landscaping and Greenery works at Dr. YSR
VUDA Central Park – Draft proposals placed before VUDA
Board Meeting for approval – Reg.**

AGENDA NOTE:-

It is submitted that, VUDA has proposed to develop the Old Central Jail site an extent of Ac 20.42 Cts into Public Park to create recreation to the public and Lungs space in the centre of city. For development of the existing site into beautiful park, the Architect / consultants have furnished conceptual designs comprising of Landscaping, Avenue and shrubbery along with Tracks & Pathways, Beautification of Entrance plaza, Bamboo Garden, Lawns including carpet grass ordinary doob grass, Shade grass etc., Flower garden, Flower beds beautification around the children park, Miniature park, open areas, Ornamental plantation Creepers in fencing areas, Development of Arches and Pagodas, Bonsai gardening, Cacti house, Green House for exotic flower etc., being the silent features of the garden. For development of landscaping Greenery and other beautification works it is estimated that an amount of Rs.3.00 Crores is proposed.

Vide Resolution no.12 dt.15-9-2011, for development of YSR Park including Landscaping and Beautification works, an amount of Rs.35.00 Crores are approved by the Board. The budget allocation for 2013-14 for development of greenery at YSR Park Central Park (functional code 4-B-77) is earmarked for an amount of Rs.2.00 Crores. Accordingly, Administrative Sanction accorded for Rs.11.39 Lakhs for Avenue plantation along with Jogging Track. And also it is further submit that the old 137 tree species was labeled and numbered for conservation purpose (List enclosed).

In continuation of the above, for the Development of Landscaping and Greenery at Dr. YSR VUDA Central Park, the proposals are placed before VUDA Board to give administrative sanction for carrying out the works above tune of Rs.2.00 Crores out of 35.00 Crores Administrative Sanction given, and the works will be executed duly taking the administrative sanction and Technical Sanction as per the procedure in vogue.
