Sub: VUDA-VSP-Estt.- Limited recruitment of backlog vacancies meant for SC / ST in the Department –Notification issued-Reg.

AGENDA NOTE :

The Government have issued orders vide G.O.Ms.No. 286, dt. 25-10-2012 of Finance (SMPC-I) Department extending the time limit for backlog vacancies of Schedule Castes / Schedule Tribes for a further period of one year up to 30-6-2013 and also permitted all the Departments to notify the backlog vacancies meant for SC/ ST which have arisen up to 31-12-2011.

In this connection, it is to submit that in pursuance of the Government orders, VUDA had issued notification on 11-06-2013 in Eenadu News paper inviting applications through website (www.vuda.gov.in) from eligible candidates for filling up 13 backlog vacancies meant for Scheduled Castes and Scheduled Tribes from 17-06-2013 to 03-07-2013. Subsequently corrigendum was published in Eenadu and on the VUDA website at www.vuda.gov.in on 16-06-2013, informing that online applications through website www.vudabacklogrecruitment2013.cgg.gov.in will be accepted from 20-06-2013 to 06-07-2013.

The following are the details of the posts reserved for backlog vacancies i.e. for SC / ST in various categories which have arisen up to 31-12-2011 in VUDA.
