

SUBJECT NO: 49

Sub : VUDA – Estate – Visakhapatnam – Regarding Paradesipalem Land Pooling Scheme in LP.No.01/2011.

AGENDA NOTE:

VUDA Board has resolved vide its Resolution No. 154 dt.18.12.2006 to develop Comprehensive Integrated Satellite Township at Paradesipalem through Land Pooling Scheme in an extent of Ac.342.36 cts. Out of the total extent of 342.36, a layout was approved vide LP no. 1/2011 dt. 30-12-2010 for an extent of Ac. 100.40 cts in which, land has been taken over possession from the land holders through “General Power of Attorney coupled with Agreement”.

Under the Board Resolution, in the following places / villages, GPA has been entertained and entered by VUDA with the following extent.

As per the above Board resolution and as per the records available, the following are the details of lands that have been taken from the private land holders under GPA totalling to 59 documents from the Paradesipalem Village as given in the ANNEXURE – I.

In pursuance to the Board resolution, the share of the land holders in the developed plots to the extent of 1800 sqyd per acre of land was provided to the maximum of the above Zeroyat land holders in the lay out developed in the Paradesipalem village by VUDA vide LP.No . 1 2011, The details were given GPA wise vide ANNEXURE - II. In the Annexure – II, the details of GPA holders who have not been given their share of developed plots have been indicated as dotted line in the respective column. In the remarks column, if they have identified their share of developed plots and has given in writing for the same, it is indicated.

After collating the above information, a meeting was held with the Zeroyat land holders to whom the share of developed plots have to be provided by VUDA on 15.05.2013 and 27.06.2013. Their details are given in annexure III.

Out of the above persons in annexure III, three categories are arrived at

1. Those lands entered GPA with VUDA but not covered in LP. No.1/2011 and requesting to opt out of Land Pooling Scheme duly withdrawing from GPA. These details are given in Annexure IV and the extent involved is ac.21.77 acres.
2. Those lands entered GPA with VUDA but not covered in LP. No. 1/2011 and have not attended the meeting and their lands can be decided to be released from GPA along with the above persons mentioned at point No.1. This category involves four documents to the extent of 7.16 acres. The documents are and details are given in Annexure-V.

3. Those lands covered in LP.No. 1/2011 and land owners have entered GPA with VUDA and these people have to be given their share of land.

The abstract of the land wise particulars of LP. No. 1/2011 vis-à-vis the actual land available as per the FMB have been analysed. Actually, layout contain 24 Sy.Nos. Out of which in 16 survey numbers, the extent got tallied and in the remaining survey numbers, there are differences and the details are given below - Annexure – VI.

The field inspection was carried out to ascertain the vacant plots available so that the vacant plots can be identified at the first instance and can be shown to the Zeroyat land owners who have to be given their share of land and also to go for disposal of the remaining plots. The list of details of vacant plots are given in Annexure – VII.

Based on the above the analysis of requirement of plots to meet the demands of the Zeroyat land owners has been arrived as below:

Now with respect to Annexure – VII, there is an availability of more than 70,000 sqyd. of developed plots including those in court dispute. Hence, VUDA is at comfortable position to execute the commitments in this LP. Scheme.

To ascertain all aspects of the issues involved, it is better to notify the details available via above Annexures-I to VI through paper notification so as to invite other documents on counter proof, if any.

With the above facts the matter is placed before the Board for taking following decisions.

1. To take a decision on releasing the lands not covered in LP.No. in 1/2011 but entered in GPA with them ie Ac. 21.77 cts. in Annexure – IV and Ac. 7.16 cts. In Annexure - totalling to Ac.28.93 cts. of land duly withdrawing the GPA entered with them as 75% of land owners of these lands have given in writing that they are willing to opt out of the Land Pooling Scheme.
2. After due verification of the GPA documents entered once again with the committee of HOD's viz. CAO, CUP, Secretary and EO as convener on the title of the land and duly collecting the relevant documents, and the relevant land owners at Annexure-III, may be allotted @ 1800 per acre of the land entered GPA as per the previous Board resolution in the vacant plots listed out in Annexure – VII, as per their choice duly excluding the plots under Court dispute.
3. In this case, the plots wherever opted are not falling in the land owner's land, the allotment of developed plots have to be executed by Registered deed as per the Board resolution.
4. These apply to few persons as indicated in Annexure-II who have been given plots by way of proceedings but could not further dispose as the same is not registered to them.
5. To proceed with the land pooling scheme further in VUDA based on the guidelines to be communicated by Government as a committee have been constituted for this purpose vide Go.Rt.No.12, MA & UD, dated 2-1-2013.

Hence, this subject is placed before the VUDA Board for approval.
