

Sub:- VUDA--PLANNING--Construction of Kalyanamandapam at Sabbavaram area--Development charges collected from Parawada Constituency area--Release of Rs.10.00 Lakhs--Approval--Reg.

VUDA has collected Rs.28.67 lakhs towards development charges from Parawada, Aganampudi and Sabbavaram Mandals from the year 1990 to March, 2000 for approvals of Residential Building applications, L.Ps, Industrial & Commercial Building Plans.

Further the Zonal Manager A.P.I.I.C., VSP has paid Rs.25.68 lakhs towards conversion charges of land use of I.D.A. Parawada. Thus, there is a total of Rs.54.35 lakhs with the VUDA towards development charges from Parawada Constituency Area.

As per G.O.Ms.No.536, MA, dated:29.9.98, 50% of the development charges are to be spent for development activities in the respective Panchayats and Municipalities. In this connection, it is also informed that the Government in the letter No.2806/H2/99-2, MA., dated:16.4.99 has permitted VUDA to take up the link road connecting Anakapalli to Pudimadaka and Sirsapalli (Via.) Vadrapalli and Munagapaka with 50% of the development charges collected from the entire Parawada M.L.A. Constituency are as per the orders issued in G.O.Ms.No.530, MA., dated:28.9.98. Hence, out of the total cost of Rs.36.00 lakhs for formation of this 40' link road with L.A. cost, VUDA's share is Rs.16.00 lakhs and R & B share is Rs.20.00 lakhs for construction of two bridges. Hence, VUDA intends to spend Rs.16.00 lakhs for formation of 40' Munagapaka link road from the development charges collected from this area.

The Dy. Executive Engineer, Panchayat Raj, Sabbavaram is his letter dated:25.4.2000 has informed while furnishing the estimated amount of Rs.17.50 lakhs along with the funding position as detailed below has requested to release 10.00 lakhs towards VUDA share for completion of Construction of the Kalyanamandapam at Sabbavaram.
