Kameswararamma informing that the claimant Kumari Saraswathula Kameswararamma B.A., B.Ed. is agreeable to the Town Planning Trust taking over possession of lands comprised in the survey nos. and sub-letters mentioned therein for the development of the area subject to the condition of naming three prominent roads after 1) Balayya sastry 2) Meenakshamma and 3) Kameswararamma.

Read delivery receipt dt.25-1-68 of Kumari S. Kameswararamma handing over possession of lands measuring acres 21-64 cents in extent to the town Planning Trust.
